BE IT ORDAINED BY THE URBANA CITY COUNCIL, that:

Section 7-5 of the Urbana City Code entitled "Height Limitations" shall be and is hereby amended in accordance with this Ordinance in the following manner:

The second sentence in subsection (a) thereof which presently reads as follows:

"If a fence is located in a required front yard, it must be of not more than thirty (30) per cent solid construction unless it is four (4) feet or less in height, in which case it may be of fifty (50) per cent solid construction."

is amended to read as follows:

"If a fence is located in a required front yard, it must be of not more than thirty (30) percent solid construction unless it is four (4) feet or less in height, in which case it may be of not more than sixty-six (66) per cent solid construction."

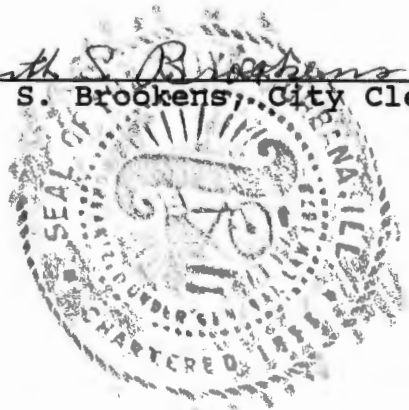
