

ORDINANCE NO. 9091-10

**AN ORDINANCE ANNEXING TERRITORY USED FOR HIGHWAY PURPOSES
TO THE CITY OF URBANA**

WHEREAS, Section 7-1-10 of the Illinois Municipal Code provides that a municipality may annex any territory which is contiguous to it even though such annexed territory dedicated or used for highway purposes under the jurisdiction of the Department of Transportation, State of Illinois; and

WHEREAS, the territory described below is such an area and is not within any other municipality; and

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Eastern Prairie Fire Protection District and includes certain Highways within the Urbana Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on July 5, 1990, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 p.m., Monday, July 16, 1990, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the 11th day of July, 1990; and

WHEREAS, the Illinois Department of Transportation has been

notified of the intention of the City of Urbana to annex the territory described below.

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

NOW, THEREFORE, BE IT ORDAINED BY THE URBANA CITY COUNCIL as follows:

Section 1. That the following described territory, which territory is dedicated for highway purposes and is under the jurisdiction of the Department of Transportation of the State of Illinois and is not a part of any other municipality and has no electors residing thereon is hereby annexed to the City of Urbana:

Commencing at the Southwest corner of the Northwest Quarter of Section 5 in Township 19 North, Range 9 East of the Third Principal Meridian; thence North 0 degrees 00 minutes 48 seconds West along the extended West line of the Southwest Quarter of said Section 5, 813.80 feet; thence Easterly along a line perpendicular to said extended West line 80.00 feet to a point on the South line of the North 7 1/2 chains of the South Half of said Northwest Quarter; thence North 4 degrees 27 minutes 26 seconds West along the existing East right-of-way line of Lincoln Avenue 18.06 feet to the place of beginning; thence continuing Northerly along said East right-of-way line 125.45 feet; thence South 79 degrees 04 minutes 01 seconds East 126.21 feet; thence South 52 degrees 03 minutes 45 seconds East 96.28 feet; thence South 24 degrees 51 minutes 31 seconds East 46.37 feet to a point on a line 18 feet North of and parallel to the South line of said North 7 1/2 chains; thence North 89 degrees 57 minutes 46 seconds West parallel to the South line of said 7 1/2 chains 209.60 feet to the place of beginning; containing 0.442 acres, more or less;

All situated in Champaign County, Illinois.

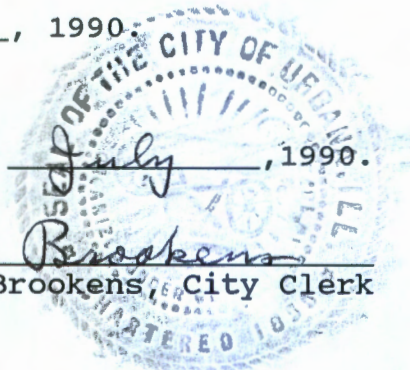
Section 2. That the City Clerk be authorized and directed to file, for record, a certified copy of this Ordinance together with an accurate map of the territory here and above described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 16th day of July, 1990.
