ORDINANCE NO. 9091-49

ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District and includes certain Highways within the Urbana Township and the Somer Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on October 3, 1990, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 p.m., Monday, October 15, 1990, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the 9th day of October, 1990; and

WHEREAS, a written petition signed by all of the owners of Record, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana; and

WHEREAS, there are no electors residing on the premises; and

WHEREAS, it has been determined that said petition complies with all requirements of the law therefore; and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

All that part of the north 60 acres of the northwest 1/4 of Section 4, Township 19 North, Range 9 East of the Third Principal Meridian, lying West of U. S. Route 45, containing 57.75 acres more or less, and all that part of the northeast 1/4 of Section 4, Township 19 North, Range 9 East of the Third Principal Meridian, lying West of U. S. Route 45, situated in Champaign County, Illinois.

Together with that portion of Willow Road right-of-way lying adjacent to said tract, encompassing 1.09 acres, more or less; also

Together with that portion of Illini Airport Road rightof-way lying adjacent to said tract, encompassing 3.86 acres, more or less; also

Together with that portion of U.S. Route 45 right-of-way lying adjacent to said tract, encompassing 3.47 acres, more or less.

All situated in Champaign County, Illinois.

Section 2. That the City Clerk be authorized and directed to file, for record, a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.
