

AN ORDINANCE  
AMENDING THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED

WHEREAS, the Urbana City Council previously passed Ordinance No. 9091-88 which was approved by the Mayor on the 2nd day of April, 1991, which said Ordinance is exactly the same in substance as this Ordinance; and

WHEREAS, due to an oversight, the said Ordinance No. 9091-88 was not published until June 19, 1991 which is more than thirty (30) days after its passage and thus it is at least arguable that the said Ordinance 9091-88 shall be not be legally effective on July 1, 1991 as anticipated; and

WHEREAS, all forms necessary to implement the revised fine schedule as set forth in Ordinance No. 9091-88 are on hand and it is necessary that the revised fine schedule go into effect as anticipated on July 1, 1991.

THEREFORE, this Council finds that there is an urgency that this Ordinance take effect immediately upon its passage and this Council so directs.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by amending the table in Section 16-1, subparagraph (b)(ii), Parking Violation Procedures, as follows:

Section 2. This Ordinance shall take effect as of midnight June 30, 1991 and the Clerk is ordered to publish this Ordinance in pamphlet form as soon as possible.

This Ordinance is hereby passed by the affirmative vote of two-thirds (2/3's) of all the members of the corporate authorities then holding office at a special meeting of said Council.
