## AN ORDINANCE AMENDING THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule IX of Section 14-3, entitled "Parking Prohibited at All Times on Certain Streets," of Article XIV, as amended, be further amended by indicating that parking shall be prohibited at any time in the area on the West side of Poplar extending 45' North from Main and that the Traffic Engineer is hereby authorized and directed to cause a sign indicating this restriction to be placed at that location.

Section 2. That Schedule VII of Section 8-3, entitled "Stop Signs Pursuant to Section 8-3," of Article VIII, as amended, be and the same is hereby further amended by adding to that schedule the intersection of Trails Drive Westbound at Philo Road where drivers of vehicles shall be required to stop before entering the intersection.

Section 3. That the Traffic Engineer is hereby authorized and directed to cause a sign reading "No Thru Semi Truck Traffic" to be posted on Bradley, facing West, approximately 75' East of Lincoln.

Section 4. That the Traffic Engineer, pursuant to Section 13-1, entitled "City Traffic Engineer to Designate Curb Loading Zones," of Article XIII, as amended, be and the same is hereby authorized and directed to establish a curb loading zone and cause the placement and maintenance of appropriate signs establishing a curb loading zone for a duration of (30) minutes on the South side of Mumford between Anderson and Lynn.

<u>Section 5.</u> That parking shall be prohibited on school days between the hours of 7:00 a.m. and 4:00 p.m. between the South parking lot of Yankee Ridge Elementary School and Eliot, and that the Traffic Engineer is hereby authorized and directed to cause a sign indicating this restriction to be placed at that location.

<u>Section 6.</u> That U-Turns shall be prohibited on Anderson between Mumford and McHenry, that the Traffic Engineer is hereby authorized and directed to cause signs indicating this restriction to be placed in the Northbound and Southbound lanes, and that Schedule II of Section 6-3 be modified accordingly.

<u>Section 7.</u> All ordinances, resolutions or motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the city of Urbana, Illinois, at a regular meeting of said council.
