ORDINANCE NO.

AN AMENDMENT TO ARTICLE III OF CHAPTER 5 OF THE CODE OF ORDINANCES, CITY OF URBANA, ILLINOIS (BUILDING CODE)

BE IT ORDAINED BY THE URBANA CITY COUNCIL, as follows:

Section 1. Section 111.5.1 of Article III entitled, "Building Code" of Chapter 5 entitled, "Building Regulations" of the Code of Ordinances, City of Urbana, Illinois is hereby added and reads as follows:

Section 111.5.1 Noxious Odor Abatement Plan:

Where plans filed with a building permit application for new construction or additions to facilities indicate an emission source which is reasonably expected to produce a noxious odor beyond that of normal mechanical systems for the facility operation, the Building Official may require a Noxious Odor Abatement Plan to be filed by the owner which shall indicate the methods proposed to be used to minimize such emissions. The plan shall utilize the best available technology as determined by the Building Official for effectuating odor reductions consistent with industry standards. If the structure is then built, the noxious odor abatement plan will be implemented substantially as proposed.

Section 2. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
