AN ORDINANCE REVISING SECTION 25-22 OF THE URBANA CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

<u>Section 1.</u> That the language of the Tree Expert Ordinance, Section 25-22, be amended as follows to reflect current practice in Illinois municipalities.

Section 25-22, Present

No person shall perform any work for hire on trees located on city owned property unless that person is licensed or directly and personally supervised by a person licensed as a tree expert as required by the state in accordance with the latest revision of the tree experts act, as such shall be amended from time to time.

Section 25-22, Revised

No person shall perform any work for hire on trees located on city owned property unless that person has been certified for competence by the Illinois Arborist Association or is being supervised by a person having this certification.

Section 2. All ordinances, resolutions or motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the city of Urbana, Illinois, at a regular meeting of said council.
