

ORDINANCE NUMBER 9192-65

AN AMENDMENT TO THE ZONING ORDINANCE

OF THE CITY OF URBANA, ILLINOIS

(Change Bakery to a Conditional Use in MOR Zoning District)

WHEREAS, the City Council of the City of Urbana, Illinois adopted Ordinance #7980-68 on December 17, 1979 which adopted the 1979 Comprehensive Amendment to the 1950 Zoning Ordinance of the City of Urbana which is also known as the Urbana Zoning Ordinance; and

WHEREAS, the purpose of the Zoning Ordinance is to implement the policies of the City of Urbana as expressed in the 1982 Comprehensive Plan as adopted by the City Council on September 7, 1982 and as said Comprehensive Plan is amended from time to time; and

WHEREAS, the Urbana City Council adopted Ordinance #9192-59 on December 2, 1991 which amended the Zoning Ordinance adopting new definitions for various types of eating establishments; and

WHEREAS, the Urbana Zoning Administrator has submitted a petition to amend the Zoning Ordinance as directed by the Urbana City Council when it adopted Ordinance #9192-59; and

WHEREAS, said petition was presented to the Urbana Plan Commission as Plan Case #1466-T-91; and

WHEREAS, after due publication in accordance with Section XI-7 of the Urbana Zoning Ordinance and with Chapter 24, Section 11-13-14 of the Illinois Revised Statutes, the Urbana Plan Commission held a public hearing on the proposed amendment on January 9, 1992; and

WHEREAS, the Urbana Plan Commission voted on January 9, 1992 to forward Plan Case #1466-T-91 and the amendment described herein to the Urbana City Council with a recommendation for approval; and

WHEREAS, after due and proper consideration, the Urbana City Council has deemed it to be in the best interests of the City of Urbana to amend the text of the Urbana Zoning Ordinance as described herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS that the Zoning Ordinance of the City of Urbana, Illinois is hereby amended as follows:

Section 1. Table V-1, Table of Uses, is hereby amended to change the designation of "Bakery (less than 2,500 sq. ft.)" from a permitted use in the MOR zoning district by changing the "P" to a "C" in the appropriate location.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 21st day of January, 1992.
