

AN ORDINANCE AMENDING THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED, ESTABLISHING RENTAL RATES FOR PARKING SPACES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the following parking rates are hereby approved for all City parking lots, excluding the City parking facility, located in the block bounded by Elm Street, Race Street, Main Street and Broadway Avenue, for rental spaces rented on a monthly basis:

\$40.00 per month for spaces rented 24 hours per day, seven days a week, and

\$20.00 per month for spaces rented between the hours of 7:00 a.m. and 6:00 p.m., Monday through Friday.

Section 2. That the daily charge for permitting the "bagging" of a parking meter shall be \$5.00 per day, payable in advance. Such charges shall not apply to those days that the meter would not be enforced.

Section 3. That the following parking rates are hereby approved for the City parking facility, located in the block bounded by Elm Street, Race Street, Main Street and Broadway Avenue, for rental spaces rented on an hourly basis:

\$0.25 per hour for each hour or portion thereof, with a maximum of \$2.75 per day.

Section 4. That the following parking rates are hereby approved for the City parking facility, located in the block bounded by Elm Street, Race Street, Main Street and Broadway Avenue, for rental spaces rented on a monthly basis:

\$60.00 per month for spaces rented 24 hours per day, seven days a week, and

\$30.00 per month for spaces rented between the hours of 7:00 a.m. and 6:00 p.m., Monday through Friday.

Section 5. Sections 3, 4, and 5 of Ordinance No. 9091-115 are hereby repealed and all other ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 6. This Ordinance shall be in full force and effect on the 1st day of May, 1992 and the City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities and in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
