

AN ORDINANCE
APPROVING AND AUTHORIZING THE EXECUTION OF AN
AGREEMENT BY AND BETWEEN THE CITY OF CHAMPAIGN, THE CITY OF
URBANA, THE URBANA & CHAMPAIGN SANITARY DISTRICT,
AND THE UNIVERSITY OF ILLINOIS RELATIVE TO THE BONEYARD CREEK
AND A CERTAIN AGREEMENT REGARDING REVISIONS TO
THE INTERGOVERNMENTAL SOLID WASTE DISPOSAL ASSOCIATION ("ISWDA")
AGREEMENT AND RETIREMENT OF ISWDA BONDS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,
ILLINOIS, as follows:

Section 1. That an Agreement between the Cities of Urbana and Champaign, the Urbana & Champaign Sanitary District and the University of Illinois relative to the Boneyard Creek, in the form of the copy of said Agreement attached hereto and hereby incorporated by reference, be and the same is hereby authorized and approved.

Section 2. That an Agreement between the Cities of Urbana and Champaign, and Champaign County Regarding Revisions to the Revised Disposal Facilities and Programs and the Creation of the Intergovernmental Solid Waste Disposal Association and Certain Payments Thereunder (Second Addendum), in the form of the copy of said Agreement attached hereto and hereby incorporated by reference, be and the same is hereby authorized and approved.

Section 3. That the Mayor of the City of Urbana, Illinois, be and the same is hereby authorized to execute and deliver and the City Clerk of the City of Urbana, Illinois, be and the same is hereby authorized to attest to said execution of said Agreements as so authorized and approved for and on behalf of the City of Urbana, Illinois.

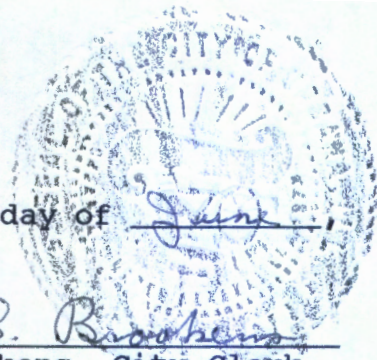
Section 4. That the Comptroller of the City of Urbana, Illinois, be and the same is hereby authorized to make payment to Busey Bank on behalf of the Intergovernmental Solid Waste Disposal Association the amount of \$804,997.00 on July 1, 1992.

Section 5. That any motions or resolutions heretofore passed by this Council which conflict with the action herein taken to approve these Agreements are hereby rescinded and held for naught.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, at a special meeting of said Council.
