

AN ORDINANCE
AMENDING THE URBANA TRAFFIC ORDINANCE, AS AMENDED

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:


Section 1. That Schedule IV-A, entitled "Right Turns Prohibited on Red", of Section 6-3 of Article VI of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by making modifications to that schedule indicating the following intersections where drivers of vehicles facing a steady red signal shall be prohibited from turning right:

<u>Street</u>	<u>Direction</u>	<u>Intersecting Street</u>
University Avenue	Eastbound	Coler Avenue
University Avenue	Westbound	Coler Avenue
University Avenue	Eastbound	Orchard Street
University Avenue	Westbound	Orchard Street
Coler Avenue	Southbound	University Avenue
Coler Avenue	Northbound	University Avenue
Orchard Street	Southbound	University Avenue
Orchard Street	Northbound	University Avenue

Section 2. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
