

ORDINANCE NO. 9293-11

**ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA**

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District and includes certain territory within the Somer Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on July 7, 1992, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 p.m., Monday, July 20, 1992, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the 16th day of July, 1992; and

WHEREAS, a written petition signed by all of the owners of Record, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana; and

WHEREAS, there are no electors residing on the premises; and

WHEREAS, it has been determined that said petition complies with all requirements of the law therefore; and

WHEREAS, the City Council passed Ordinance No. 9192-64 on January 21, 1992 approving and authorizing the execution of an annexation agreement wherein the Corporate Authorities agreed to expeditiously annex said territory; and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

The East 200 feet of the Southwest Quarter of the Northwest Quarter of Section 33, Township 20 North, Range 9 East of the Third Principal Meridian situated in Champaign County, Illinois; and

The North Half of the Southwest Quarter and all of the South Half of the Northwest Quarter of the Southeast Quarter that lies West of Route 45, and that part of the North 24 Rods of the North Half of the Southwest Quarter of the Southeast Quarter that lies West of Route 45, all in Section 33, Township 20 North, Range 9 East of the Third Principal Meridian situated in Champaign County, Illinois

Except;

A 60 foot wide tract of land being situated in the North One Half of the Southwest Quarter of said Section 33 as described in a Common Law Dedication of Right-of-Way recorded in Book 1630 at page 588 in the office of the Recorder, Champaign County, Illinois.

The above described tract containing 101.82 acres, more or less.

Together with the following described adjacent public Rights-of-Way which are by operation of the law, automatically annexed with the adoption of an Annexation Ordinance pertaining to this parcel:

A 60 foot wide tract of land being situated in the North One Half of the Southwest Quarter of said Section 33 as described in a Common Law Dedication of Right-of-Way recorded in Book 1630 at page 588 in the office of the Recorder, Champaign County, Illinois, encompassing 3.14 acres, more or less, and

That portion of Route 45 Right-of-Way that lies adjacent to the above described tract, encompassing 2.54 acres, more or less.

All situated in Champaign, County, Illinois.

commonly known for reference as 3007 N. Cunningham Avenue, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcels, prior to annexation, have the permanent index numbers 25-15-33-100-017 (part of), 25-15-33-300-001, and 25-15-33-402-006, and following annexation the said parcels should bear the permanent index numbers 91-21-33-100-017, 91-21-33-300-001, and 91-21-33-402-006.

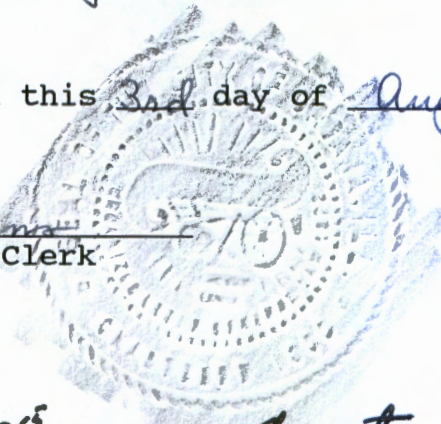
Section 2. That the City Clerk be authorized and directed to file, for record, a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 3rd day of August, 1992, A.D.
