

ORDINANCE NO. 9293-18

AN ORDINANCE AMENDING SECTION 5-2 OF THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED, ESTABLISHING SPEED REGULATIONS ON A PORTION OF PHILO ROAD

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule I of Section 5-2 of Article V, entitled "Speed Regulations", of the Urbana Local Traffic Ordinance, as amended, is hereby further amended by adding to that schedule the following speed regulations for a certain portion of Philo Road:

From Washington Street to Fairlawn Drive the speed limit shall be thirty miles per hour (30 MPH) in either direction.

Section 2. That the Traffic Engineer is hereby authorized and directed to post the appropriate signs indicating the speed regulations set forth in this Ordinance.

Section 3. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
