## ORDINANCE NO. 9293-20

## AN ORDINANCE AMENDING THE URBANA TRAFFIC ORDINANCE, AS AMENDED TO ESTABLISH A NO PARKING AND TOW-AWAY ZONE ON VINE STREET

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule X, pursuant to Section 14-4, entitled "Parking Prohibited During Certain Hours on Certain Streets", of Article XIV of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by adding to that schedule the following portion of street where parking shall be prohibited between the hours of 8:00 A.M. to 4:00 P.M. on days when school is in session:

<u>Street</u> <u>From</u> <u>To</u> <u>Side</u>

Vine St. Fairlawn Dr. 200 feet north of West Fairlawn Dr.

Section 2. That Schedule XII, pursuant to Section 14-11, entitled "Tow-Away Zones", of Article XIV of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by adding to that schedule the following portion of street which shall be established as a tow-away zone:

<u>Street</u> <u>From</u> <u>To</u> <u>Side</u>

Vine St. Fairlawn Dr. 200 feet north of West Fairlawn Dr.

Section 3. All ordinances, resolutions, or motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
