ORDINANCE NO. 9293-54

AN ORDINANCE AMENDING SECTION 8-3 OF THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED, ESTABLISHING A STOP SIGN AT BEVERLY DRIVE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule VII of Section 8-3, entitled "Stop Signs Pursuant to Section 8-3", of Article VIII of the Urbana Local Traffic Ordinance, as amended, is hereby further amended by adding to that schedule the following intersection where drivers of vehicles shall be required to stop before entering the intersection:

Beverly Drive Westbound at Lincoln Avenue

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative wote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.




