

AN ORDINANCE AMENDING THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED, RESTRICTING PARKING ON VINE STREET BETWEEN FAIRLAWN DRIVE AND MICHIGAN AVENUE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:


Section 1. That Schedule X of Section 14-4, entitled "Parking Prohibited During Certain Hours of Certain Streets", of Article XIV of the Urbana Local Traffic Ordinance, as amended, is hereby further amended by adding to that schedule the West side of Vine Street between Fairlawn Drive and Michigan Avenue where parking shall be prohibited every day between the hours of 2:00 am and 6:00 am during the period from November 1 through March 31.

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
