

AN ORDINANCE  
AMENDING THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,  
ILLINOIS, as follows:

Section 1. That the City Traffic Engineer, pursuant to Section 13-1, entitled "City Traffic Engineer to Designate Curb Loading Zones", of Article XIII of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby authorized and directed to establish a curb loading zone and cause the placement and maintenance of appropriate signs establishing a curb loading zone for a duration of fifteen (15) minutes on the following portion of a street:

| <u>Street</u> | <u>Location</u>   | <u>Side of Street</u> |

| Harding Drive | A portion from 120 to 160 feet West of the centerline of Cottage Grove Avenue | North                 |

Section 2. That Schedule VII, entitled "Stop Signs Pursuant to Section 8-3", of Section 8-3, of the Urbana Local Traffic Ordinance, as amended, be further amended by adding to that Schedule the following intersection where drivers of vehicles shall be required to stop before entering the intersection:

Busey Avenue Northbound at Fairview Avenue  
Busey Avenue Southbound at Fairview Avenue

Section 3. That Schedule VII, entitled "Stop Signs Pursuant to Section 8-3", of Section 8-3, of the Urbana Local Traffic Ordinance, as amended, be further amended by deleting from that Schedule the following intersection where drivers of vehicles shall no longer be required to stop before entering the intersection:

Fairview Avenue Eastbound at Busey Avenue  
Fairview Avenue Westbound at Busey Avenue

Section 4. That Schedule IX of Section 14-3, entitled "Parking Prohibited At All Times On Certain Streets", of the Urbana Local Traffic Ordinance, as amended, be hereby further amended by adding to that Schedule the following portions of streets where parking shall be prohibited at any time:

| Linview Avenue | Southbound from Killarney Street to Kettering Park Drive | West                  |

Section 5. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 6. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
