

AN ORDINANCE
AMENDING THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,
ILLINOIS, as follows:

Section 1. That Schedule IX of Section 14-3, entitled "Parking Prohibited At All Times On Certain Streets", of the Urbana Local Traffic Ordinance, as amended, be hereby further amended by adding to that Schedule the following portions of streets where parking shall be prohibited at any time:

<u>Street</u>	<u>Location</u>	<u>Side of Street</u>
Springfield Avenue	Westbound from Goodwin Avenue to Wright Street	North
Mathews Avenue	Northbound from Springfield Avenue East to Main Street	

Section 2. That Schedule VII, entitled "Stop Signs Pursuant to Section 8-3", of Section 8-3, of the Urbana Local Traffic Ordinance, as amended, be further amended by adding to that Schedule the following intersection where drivers of vehicles shall be required to stop before entering the intersection:

Mathews Avenue Northbound at Main Street
Mathews Avenue Southbound at Main Street
Main Street Westbound at Mathews Avenue
Main Street Eastbound at Mathews Avenue

Section 3. That Section V, of Section 7-2, entitled "One-Way Streets and Alleys", of the Urbana Local Traffic Ordinance, as amended, be further amended by adding to that Schedule the following portion of a street where vehicular traffic shall move only in the indicated direction:

<u>Name of Street/Alley</u>	<u>From</u>	<u>To</u>	<u>Direction of Traffic</u>
Mathews Avenue	Springfield Avenue	Main Street	Northbound

Section 4. That pursuant to Section 17-1, entitled "Authority to Establish Parking Meter Zones", of the Urbana Local Traffic Ordinance, as amended, the City Council hereby approves the establishment of a parking meter zone upon the following portion of such street:

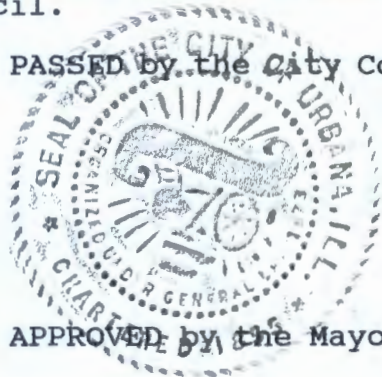
<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side</u> of <u>Street</u>
Springfield Avenue	Goodwin Avenue	Wright Street	South Side
Mathews Avenue	Springfield Avenue	Main Street	West Side

Section 5. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 6. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
