## AN AMENDMENT TO A PART OF THE ZONING ORDINANCE OF THE CITY OF URBANA, ILLINOIS AND THE ZONING MAP OF URBANA, ILLINOIS

## 1908 N. Lincoln Avenue

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on August 5, 1993 concerning the Petition filed by Brock Oil Company in Plan Case No. 1512-M-93; and

WHEREAS, the Urbana Plan Commission has forwarded the case to the Urbana City Council with a recommendation to approve the request so that the property herein described below and commonly known as 1908 N. Lincoln Avenue will be rezoned from IN (Industrial) to B-3 (General Business); and,

WHEREAS, the requested rezoning conforms to the goals, objectives and policies of the City of Urbana's Comprehensive Plan, as amended.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, THAT:

<u>Section 1.</u> The Zoning Ordinance of the City of Urbana and the Zoning Map of Urbana, Illinois, are herewith and hereby amended to change the zoning classification of the following described area from IN (Industrial) to B-3 (General Business):

Tax Parcel #91-21-05-301-011, Lot 6 in Lincoln Centre in Champaign County, Illinois as per plat recorded in Plat Book "Z" at page 70 in Champaign County, Illinois, commonly known as 1908 North Lincoln Avenue.

The said area above described being represented on the map attached hereto and incorporated herein by reference.

<u>Section 2.</u> The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 164 day of August, 1993.
