

AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE

WHEREAS, it is desirable and in the best interests of the City of Urbana, Illinois to amend a License Agreement Between the City of Urbana, Illinois and the Board of Trustees of the University of Illinois, dated July 24, 1991; and

WHEREAS, a written copy of such Amendment No. 1 to a License Agreement is now before this meeting.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the Council hereby approves the City entering into Amendment No. 1 to License Agreement Between the City of Urbana, Illinois and the Board of Trustees of the University of Illinois.

Section 2. That the Mayor is hereby authorized to execute and deliver such Amendment to an Agreement on behalf of the City. The amendment to the agreement shall be in substantially the form of the Amendment which is before this Council, a copy of which is attached hereto and incorporated herein. The City Clerk is authorized to attest to such execution thereof.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.

ORDINANCE NO. 9394-68

AN ORDINANCE  
REVISING THE ANNUAL BUDGET ORDINANCE

WHEREAS, the Annual Budget Ordinance of and for the City of Urbana, Champaign County, Illinois, for the fiscal year beginning July 1, 1993, and ending June 30, 1994, (the "Annual Budget Ordinance") has been duly adopted according to sections 8-2-9.1 et seq. of the Illinois Municipal Code (the "Municipal Code") and Division 2, entitled "Budget", of Article VI, entitled "Finances and Purchases", of Chapter 2, entitled "Administration", of the Code of Ordinances, City of Urbana, Illinois (the "City Code"); and

WHEREAS, the City Council of the said City of Urbana finds it necessary to revise said Annual Budget Ordinance by deleting, adding to, changing or creating sub-classes within object classes and object classes themselves; and

WHEREAS, funds are available to effectuate the purpose of such revision; and

WHEREAS, such revision is not one that may be made by the Budget Director under the authority so delegated to the Budget Director pursuant to section 8-2-9.6 of the Municipal Code and section 2-133 of the City Code.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the Annual Budget Ordinance be and the same is hereby revised to provide as follows:

FUND:	Supplementary Reserve
AMOUNT:	\$102,000
ADD TO:	Excel Settlement

Section 2. This Ordinance shall be effective immediately upon passage and approval and shall not be published.

Section 3. This Ordinance is hereby passed by the affirmative vote of two-thirds of the members of the corporate authorities then holding office, the "ayes" and "nays" being called at a regular meeting of said council.

AMENDMENT NO. 1

LICENSE AGREEMENT BETWEEN

Whereas, the University desires to amend the License Agreement dated July 24, 1991, this agreement is in connection with the construction of an electrical feed for the Chemical and Life Sciences Laboratory:

This amendment extends a nonexclusive permanent license for an electrical feed for the Chemical and Life Sciences Laboratory in the Goodwin Avenue right-of-way from manhole in the intersection of Oregon Street south to the south right-of-way of Nevada Street which begins the University's property. 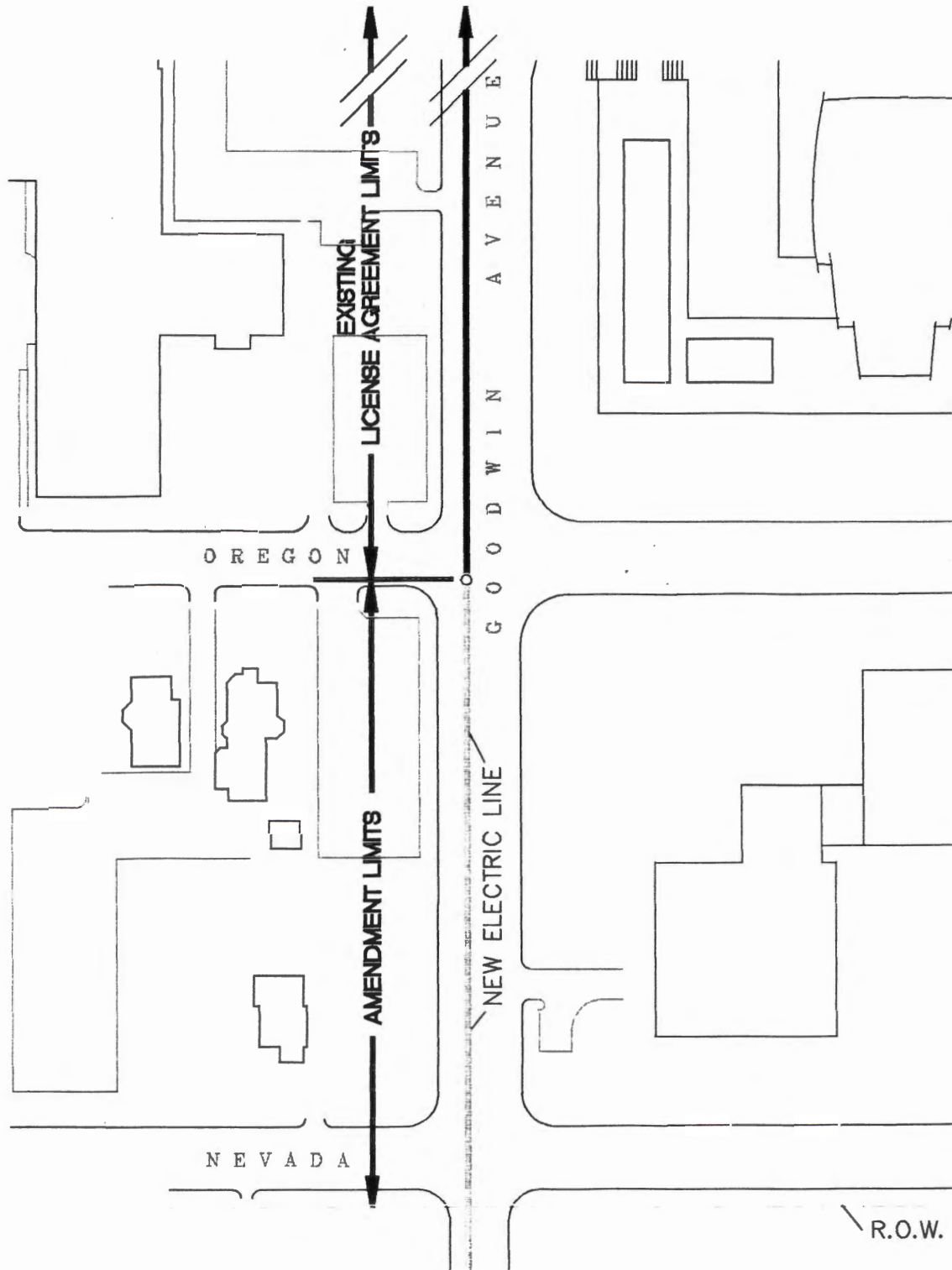
