AN ORDINANCE NAMING ROAD RIGHT-OF-WAY

WHEREAS, The Illinois Department of Transportation on May 9, 1993 has transferred jurisdiction of the right-of-way of the frontage roads at the Lincoln avenue and Interstate 74 interchange; and

WHEREAS, new right-of-ways were created and dedicated at the southwest corner of said interchange in order to terminate Kenyon Road at its intersection with Lincoln Avenue and realign it with existing Killarney Street to the east; and

WHEREAS, the said right-of-ways as shown on the attached Location Map have never been assigned an official name and the City desires to bring these new roads into conformance with the existing street name system; and

WHEREAS, the said right-of-ways, being within the corporate limits of the City of Urbana, are to be named by the corporate authorities of the City of Urbana.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

<u>Section 1.</u> That the following described public right-of-way is hereby designated with the name of "Gregory Street".

A road in the Northeast Quarter of the Southwest Quarter of Section 6, Township 19 North, Range 9 East of the Third Principal Meridian, further described as follows:

All of the north-south frontage road lying approximately five hundred ten feet (510') west of Lincoln Avenue, between the south edge of Kenyon Road and a line approximately four hundred fifty feet (450') south of said south edge. Situated in the City of Urbana, Champaign County, Illinois.

Section 2. That the following described public right-of-way is hereby designated with the name of "Killarney Street".

A road in the Northeast Quarter of the Southwest Quarter of Section 6, Township 19 North, Range 9 East of the Third Principal Meridian, further described as follows:

All of the east-west frontage road lying approximately three hundred ninety feet (390') south of Kenyon Road, between the west edge of Lincoln Avenue and the east edge of the northsouth frontage road lying approximately five hundred ten feet (510') west of Lincoln Avenue (Gregory Street). Situated in the City of Urbana, Champaign County, Illinois.

Section 3. That the existing Kenyon Road right-of-way shall retain the name of Kenyon Road to its terminus west of Lincoln Avenue;

Section 4. That certified copies of this Ordinance and Location Map be delivered to the Champaign County Clerk, the United States Postal Service branch office serving the area, and the District Engineer of the Illinois Department of Transportation in Paris, Illinois by certified or registered mail.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular mee said Council.
