## ORDINANCE NUMBER 9394-82

## AN ORDINANCE APPROVING AND CAUSING PUBLICATION OF THE OFFICIAL ZONING MAP OF THE CITY OF URBANA, ILLINOIS

WHEREAS, the Illinois Municipal Code requires the City Council of the City of Urbana, Illinois to cause to be published each year a map showing the existing zoning classifications and revision made during the preceding calendar year and the map so published shall be the Official Zoning Map for the City of Urbana; and

WHEREAS, the City Council of the City of Urbana last approved an Official Zoning Map on March 15, 1993 in Ordinance No. 9293-89; and

WHEREAS, the Urbana Zoning Administrator has submitted a request to approve the revised Official Zoning Map; and

WHEREAS, said request was presented to the Urbana Plan Commission as Plan Case No. 1529-M-94; and

WHEREAS, the Urbana Plan Commission reviewed the proposed new Official Zoning Map on March 10, 1994 and voted to forward Plan Case No. 1529-M-94 to the Urbana City Council with a recommendation for approval of the new Official Zoning Map; and

WHEREAS, after due and proper consideration, the Urbana City Council has deemed it to be in the best interests of the City of Urbana to approve the new Official Zoning Map.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS as follows:

Section 1. That the attached map entitled Official Zoning Map of Urbana, Illinois dated March 21, 1994 be and the same is hereby approved as the Official Zoning Map of the City of Urbana, Illinois pursuant to Chapter 24, Section 11-13-19 of the Illinois Revised Statutes, and Section IV-3 of the Urbana Zoning Ordinance, which said map reflects the correct location of the official zoning districts in the City of Urbana as of March 21, 1994.

<u>Section 2.</u> That the City Clerk is hereby directed to publish a full-sized copy of the Official Zoning Map and to make copies available in her office for inspection and purchase by the public.

<u>Section 3.</u> That the fee to be charged to any person desiring to purchase a full-sized copy of the Official Zoning Map shall be Five Dollars (\$5.00) per map.

<u>Section 4.</u> The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the members of the City Council of the City of Urbana, Illinois, at a meeting of said Council on the 21st day of man, 1994.
