AN ORDINANCE ABATING THE DIRECT ANNUAL TAX LEVIED TO PAY THE INTEREST ON AND PRINCIPAL OF CORPORATE PURPOSE GENERAL OBLIGATION BONDS, SERIES 1990, OF THE CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS

8990-87, WHEREAS, pursuant to Ordinance No. ORDINANCE AUTHORIZING THE ISSUANCE OF \$3,890,000 CORPORATE PURPOSE GENERAL OBLIGATION BONDS, SERIES 1990, OF THE CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS PROVIDING THE DETAILS OF SUCH BONDS AND THE THE LEVY OF DIRECT ANNUAL TAXES TO PAY THE PRINCIPAL OF AND INTEREST ON SUCH BONDS, AND RELATED MATTERS (the "Prior Bond Ordinance"), adopted by the City Council (the "Corporate Authorities") of the City of Urbana, Champaign County, Illinois (the "City"), on March 5, 1990, the City, on March 16, 1990, issued its Corporate Purpose General Obligation Bonds, Series 1990, under and pursuant to the Prior Bond Ordinance in the aggregate principal amount of \$3,890,000 (the "Prior Bonds") in order to finance the costs of certain public projects, including certain redevelopment project costs under the Tax Increment Allocation Redevelopment Act for the Redevelopment Project Area No. 2; and

WHEREAS, under Section 9 of Ordinance No. 8990-87 constituting the Prior Bond Ordinance, the Corporate Authorities levied upon all taxable property within the City a direct annual tax in and for each of the years 1990 through 2003, inclusive, while the Prior Bonds or any of them were outstanding; and

WHEREAS, pursuant to Ordinance No. 9394-99 ORDINANCE OF THE CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS, PROVIDING FOR THE ISSUANCE OF GENERAL OBLIGATION TAX INCREMENT REFUNDING BONDS, SERIES 1994A AND SERIES 1994B, AND GENERAL OBLIGATION REFUNDING BONDS, SERIES 1994C, PROVIDING THE DETAILS OF SUCH BONDS AND FOR A LEVY OF TAXES TO PAY THE PRINCIPAL OF AND INTEREST ON SUCH BONDS AND FOR CERTAIN REVENUE SOURCES TO PAY AND SECURE THE PRINCIPAL OF AND INTEREST ON SUCH SERIES 1994A AND SERIES 1994B BONDS, AND RELATED MATTERS (the "Bond Ordinance"), adopted by the Corporate Authorities on May 16, 1994, the City, on June 1, 1994, issued its General Obligation Tax Increment Refunding Bonds, Series 1994B, in the principal amount of \$1,975,000 and its General Obligation Refunding Bonds, Series 1994C, in the principal amount of \$1,740,000 (collectively, the "Bonds"), the proceeds of which, together with other amounts legally available therefor, were applied to fund an escrow account sufficient to pay the principal of, premium, if any, and interest on the outstanding Prior Bonds maturing on and after March 1, 1995; and

WHEREAS, under Section 8 of the Bond Ordinance, the Corporate Authorities levied upon all taxable property within the City a direct annual tax in and for each of the years 1994 through 2011, inclusive, while the Bonds or any of them are outstanding; and

WHEREAS, upon the issuance of the Bonds and the funding of the escrow as described above of funds sufficient to pay the principal of, premium, if any, and the interest on the outstanding Prior Bonds maturing on and after March 1, 1995, the City has caused the defeasance of the Prior Bonds maturing on and after March 1, 1995, with respect to which it is now appropriate and the Corporate Authorities are now authorized to abate the direct annual tax levied for such outstanding Prior Bonds maturing on and after March 1, 1995, under and pursuant to the provisions of Section 9 of Ordinance No. 8990-87 constituting the Prior Bond Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. Abatement. The direct annual tax levied upon all taxable property in the City in and for each of the years 1994 through 2003, as provided in Section 9 of Ordinance No. 8990-87 constituting the Prior Bond Ordinance, (filed on the 14th day of March, 1990, in the office of the County Clerk of the County of Champaign, Illinois) be abated in and for each of the years 1994 through 2003, inclusive, as follows:

Section 2. Filing. As soon as this Ordinance becomes effective, a certified copy hereof shall be filed with the County Clerk of the County of Champaign, Illinois, who is hereby directed to abate such direct annual taxes as set forth above in Section 1 in and for each of the years 1994 through 2003, inclusive.

Section 3. Effective Date. This Ordinance shall become effective immediately upon its passage and approval as required by law.
