

ORDINANCE NO. 9495-22

AN ORDINANCE AMENDING SECTIONS 13-2, 14-4 AND 14-10 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING ON CERTAIN STREETS AND ESTABLISHING TOW AWAY ZONES AND ESTABLISHING CURB LOADING ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule K of §14-4, entitled "Parking Prohibited During Certain Hours on Certain Streets", of Article XIV of the Urbana Local Traffic Code, is hereby amended by deleting from that schedule the following portions of certain streets where no person shall park a vehicle:

	No Parking on School Days 7AM - 4 PM		
Vine	Northbound	Michigan to Fairlawn	East
Vine	Southbound	Fairlawn to Michigan	West

	No Parking School Days 8AM - 4PM		
Vine	Northbound	200 Feet Past Fairlawn	West

Section 2. That Schedule K of §14-4, entitled "Parking Prohibited During Certain Hours on Certain Streets", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following portions of certain streets where no person shall park a vehicle:

	No Parking on School Days 8AM - 4PM		
Vine	Northbound	Pennsylvania to Hollywood	East
Vine	Southbound	Fairlawn to 196' North of the centerline of Michigan	West
Vine	Southbound	Michigan to Pennsylvania	West

Section 3. That Schedule M of §14-10, entitled "Tow Away Zones", of Article XIV of the Urbana Local Traffic Code, is hereby amended by deleting from that schedule the following portions of certain streets which shall be established as tow away zones:

Vine	Fairlawn	200' N. of Fairlawn	West

Section 4. That Schedule M of §14-10, entitled "Tow Away Zones", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following portions of certain streets which shall be established as tow away zones:

Vine	Northbound	Pennsylvania to Hollywood	East
Vine	Southbound	Fairlawn to Pennsylvania	West

Section 5. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 6. That Schedule J of § 13-2, entitled "Standing in Curb Loading Zone" of Article XIII of the Urbana Local Traffic Code is hereby amended by adding to that Schedule the following portions of certain streets which shall be established as a fifteen (15) minute loading zone:

Vine	Southbound	From 196' North of the centerline of Michigan to 70' North of the centerline of Michigan	West
------	------------	--	------

Section 7. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 8. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.


