

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 8-3 AND SCHEDULE J OF SECTION 14-3 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT CERTAIN INTERSECTIONS AND NO PARKING THIS SIDE OF STREET

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 8-3, entitled "Stop Signs Pursuant to Section 8-3", of Article VIII of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersection:

Coler Northbound at Fairview
Coler Southbound at Fairview
Church Eastbound at Orchard
High Eastbound at Urbana
High Westbound at Urbana
Broadway Northbound at High
High Eastbound at Broadway
High Westbound at Broadway
High Eastbound at Walnut

Section 2. That Schedule J of Section 14-3, entitled "No Parking This Side of Street", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following portion of a street where no parking will be permitted. The City Engineer will cause a sign to be erected to that effect:

Walnut Southbound from Illinois to High West

Section 3. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.

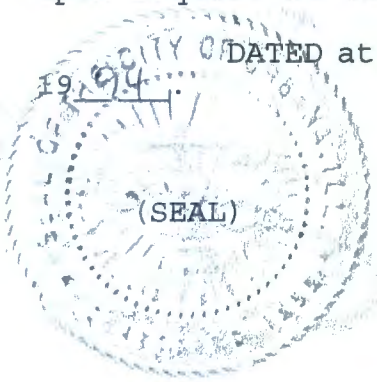
CERTIFICATE OF PUBLICATION IN PAMPHLET FORM
