### DENIAL OF A REQUEST TO AMEND PART OF THE ZONING ORDINANCE OF THE CITY OF URBANA, ILLINOIS AND THE ZONING MAP OF URBANA, ILLINOIS

#### The Western Two Lots at 1303 N. Cunningham Avenue

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on July 7 and July 21, 1994 concerning the Petition filed by Frank DiNovo, on behalf of Champaign County, in Plan Case #1536-M-94; and

WHEREAS, the Urbana Plan Commission has forwarded the case to the Urbana City Council with a recommendation to deny the requested rezoning of the properties herein described below and commonly known as 1303 N. Cunningham Avenue; and

WHEREAS, the request to rezone the western two lots at 1303 N. Cunningham Avenue from R-3, Single and Two-family Residential, to R-4, Medium Density Multiple Family Residential does not conform to the City of Urbana's Comprehensive Plan;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, THAT:

<u>Section 1.</u> The petitioner's request to rezone the following described area commonly known as the western two lots at 1303 N. Cunningham Avenue from R-3, Single- and Two-Family Residential to R-4, Medium Density Multiple Family Residential is hereby denied:

The western two-thirds of Tax Parcel #92-21-09-100-001, lots 2 and 3 of the Subdivision of the Northwest 1/4 of Section 8 and the West 1/2 of the Northe\west 1/4 of Section 9, Section 9, Township 18 North, Range 9 East of the Third Principal Meridian, Urbana Township, Champaign County, commonly known as 1303 N. Cunningham Avenu, Urbana, Illinois.

The said area above described being represented on the map attached hereto and incorporated herein by reference.

<u>Section 2.</u> The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the Members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council.


