## ORDINANCE NO. 9495-34

## AN ORDINANCE PROVIDING FOR A PROVISIONAL TAXICAB DRIVERS LICENSE

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

<u>Section 1.</u> The following sections of Chapter 26 of the Urbana City Code are hereby amended to read as follows:

Sec. 26-45. Character of Applicant Driver.

No taxicab driver's license, including a provisional license, shall be issued to or held by any person:

- (1) Whose taxicab driver's license has been revoked during the preceding six (6) months; or
- (2) Who the issuing authority finds, for some other reason, should not be granted a license. The issuing authority making this determination shall consider any conviction of a felony or misdemeanor involving moral turpitude, if relevant to the license, the recency of such conviction, and the applicant's demeanor and conduct subsequent to the conviction.

Sec. 26-49. Fee.

The annual license fee for a taxicab driver's license shall be as prescribed in Section 14-7 of this Code. The driver's license fee shall not be prorated for a fractional part of the year. There shall be no separate fee for the issuance of a provisional license. There shall be no rebate of fees paid if the annual license is not issued.

Sec. 26-50. Expiration.

Each license, other than a provisional license, issued under this division shall expire on the thirtieth day of June of the fiscal year for which they are issued.

Sec. 26-52. Revocation.

- (1) The Mayor may revoke any taxicab driver's license, including a provisional license, for repeated violations of traffic laws or ordinances, or when a driver's license issued pursuant to the Illinois Vehicle Code is suspended or revoked. A provisional license shall be revoked as provided in Section 26-54.
- (2) It shall be the duty of any person whose driver's license shall have been revoked as herein provided, to return immediately every such license, driver's badge, etc., to the Comptroller.

THIS ORDINANCE CONSISTS OF 2 PAGES.

Section 2. The following new section is added to Chapter 26 of the Urbana City Code:

Sec. 26-54. Provisional License.

- (A) The issuing authority may issue a provisional taxicab driver's license to a person who has applied for a taxicab driver's license if the issuing authority finds the applicant is qualified for a taxicab driver's license, but at the time of issuance, the issuing authority has not received information from the State of Illinois regarding the existence or non-existence of a criminal history of the applicant.
- (B) Such provisional license shall be valid for 60 days from the date of issuance, but shall expire sooner upon the issuance of the annual taxicab driver's license that the applicant applied for.
- (C) The provisional license shall be revoked immediately upon receipt of information that would disqualify the applicant under Section 26-54. The applicant shall be notified of such in writing.

<u>Section 3.</u> The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and the Ordinance shall be in full force and effect from and after the passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of urbana, Illinois at a regular meeting of said Council.


