

ORDINANCE NO. 9495-38

AN ORDINANCE AMENDING SECTION 14-3 AND SCHEDULE L OF SECTION 14-7 OF ARTICLE XVII OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING ON CERTAIN STREETS AND DESIGNATING YELLOW CURBS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule L of Section 14-7, entitled "Curb Painted Yellow by Order Of The City Council", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following areas of curbs which are to be painted yellow:

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
Busey	From the centerline of Church to 95' North of the centerline of Church		West
Busey	From the centerline of Church to 80' South of the centerline of Church		West
Clark	From the centerline of Busey to 70' East of the centerline of Busey		South
Coler	From the centerline of Church to 104' South of the centerline of Church		East
Coler	From the centerline of Clark to 87' South of the centerline of Clark		West
Fairview	From the centerline of Coler to 77' West of the centerline of Coler		South

Section 2. That Schedule J of §14-3, entitled "Parking Prohibited at All Times on Certain Streets", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following portion of a street where no person shall park a vehicle:

No Parking Either Side

Goodwin From University to Park

No Parking This Side of Street

Race Northbound From Michigan to 85 Feet East
Past Michigan

Section 3. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.


