

ORDINANCE NO. 9495-48

AN AMENDMENT TO A PART OF THE ZONING ORDINANCE OF THE CITY OF URBANA, ILLINOIS AND THE ZONING MAP OF URBANA, ILLINOIS

1704 S. Cottage Grove Avenue

(Plan Case No. 1549-M-94)

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on November 10, 1994 concerning the Petition filed by Brian Deal and Robert Nemeth in Plan Case #1549-M-94; and

WHEREAS, the Urbana Plan Commission has forwarded the case to the Urbana City Council with a recommendation to approve the requested rezoning of the property herein described below and commonly known as 1704 S. Cottage Grove; and

WHEREAS, the City of Urbana's Comprehensive Plan recommendation of a commercial use for this property is inappropriate given the pace of commercial development in the area and the proximity of existing residential uses to the property; and

WHEREAS, the subject property is not well-suited for single family residential development because of its proximity to an apartment building complex immediately to the east, duplexes to the north and the intersection of a minor arterial and collector street; and

WHEREAS, the proposed R-3 District will promote the development of the property with a duplex residential structure, a use not permitted by right in the current R-2 District; and

WHEREAS, duplex development will provide a more appropriate transitional land use at this location between the multi-family development to the east and single family homes to the west; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, THAT:

Section 1. The Zoning Ordinance of the City of Urbana and the Zoning Map of Urbana, Illinois, are herewith and hereby amended to change the zoning classification of the following described area so that the property commonly known as 1704 S. Cottage Grove will be rezoned from R-2, Single Family Residential to R-3, Single and Two Family Residential:

Tax Parcel #93-21-21-126-021, including all of lot 3 of Kurasek Subdivision, Urbana, Illinois, as per Plat recorded in Book Y, Page 284, in the Office of the Recorder, Champaign County, Illinois. Said lot containing 10,742 square feet, more or less, and all of said lot situated in the City of Urbana, in Champaign County, Illinois.

The said area above described being represented on the map attached hereto and incorporated herein by reference.

Section 2. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities. This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Chapter 65, Section 1-2-4 of the Illinois Compiled Statutes (65 ILCS 5/1-2-4).

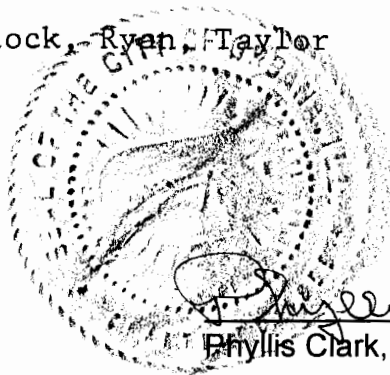


