

ORDINANCE NO. 9495-55

AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A CHANGE ORDER TO MODIFY THE AGREEMENT FOR CONSULTANT SERVICES WITH CROWE CHIZEK REGARDING CABLE RATE REGULATION

WHEREAS, the City of Urbana, together with the City of Champaign, previously entered into an agreement with the accounting firm of Crowe Chizek to provide consultant services regarding cable rate regulation, specifically the review of FCC Form 393, and

WHEREAS, the City of Urbana has determined that the agreement should be modified to increase the scope of services to include the review of FCC Forms 1200, 1205, and 1215, and to increase the original contract price from \$3,600 - \$4,500 to \$9,700 - \$11,700.

WHEREAS, a written copy of a change order has been presented to and is now before this meeting.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the Council hereby approves the City of Urbana, together with the City of Champaign, entering into a change order to modify the agreement for consultant services with Crowe Chizek regarding cable rate regulation.

Section 2. That the Mayor is hereby authorized to execute and deliver such a change order on behalf of the City. The change order shall be in substantially the form of the change order which is before this Council, a copy of which is attached hereto and incorporated herein. The City Clerk is authorized to attest to such execution thereof.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.



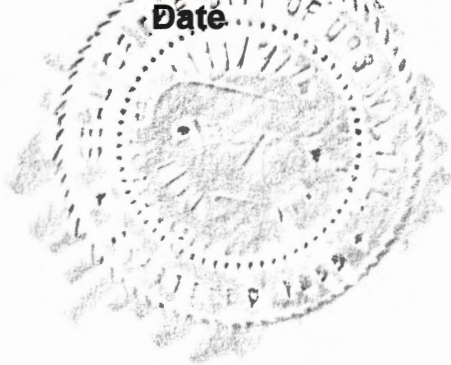

The following changes are hereby made to the CONTRACT DOCUMENTS: Contractor agrees to perform rate review, with written results, for FCC Forms 1200, 1205 & 1215 as submitted by CableVision, a Time Warner subsidiary for Champaign and Urbana.

Justification: Because of local scrutiny paid by subscribers in C-U, staff believes a more thorough, experienced review would be most effective and efficient by a neutral party in this case, including review of requests for rate increase for new "home terminal".

Change to CONTRACT PRICE:

The CONTRACT PRICE DUE to this CHANGE ORDER will be \$6,100 - \$7,200 increased by:
