

ORDINANCE NO. 9495-56

AN ORDINANCE AMENDING CHAPTER 9.5 OF THE CODE OF ORDINANCES, CITY OF URBANA, ILLINOIS REGULATING THE LICENSING OF RAFFLES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Section 9.5-21 of Article II, "Raffles", of Chapter 9.5, "Games of Chance", of the Code of Ordinances, City of Urbana, Illinois, is hereby amended to read as follows:

Sec. 9.5-21. License required.

Except as provided in Sec. 9.5-30, no person, firm or corporation shall conduct raffles or chances in the City without having first obtained a license therefor pursuant to this article.

Section 2. That Article II, "Raffles", of Chapter 9.5, "Games of Chance", of the Code of Ordinances, City of Urbana, Illinois, is hereby amended by adding Section 9.5-30 to read as follows:

Section 9.5-30. Reciprocity.

The provisions of this article shall not apply to a raffle conducted by an organization which has been licensed by the City of Champaign or Champaign County, provided that the organization would be eligible under Sec. 9.5-22.

Section 3. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 4. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected

Section 5. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.



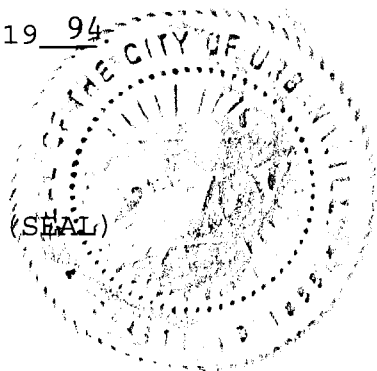
I, PHYLLIS D. CLARK, certify that I am the duly elected and acting Municipal Clerk of the City of Urbana, Champaign County, Illinois.
