## ORDINANCE NO. 9495-88

## AN ORDINANCE AMENDING SECTIONS 14-4 AND 14-10 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING ON SPRINGFIELD

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

<u>Section 1.</u> That Schedule J of §14-4, entitled "Parking Prohibited During Certain Hours on Certain Streets", of Article XIV of the Urbana Local Traffic Code, is hereby amended by deleting from that schedule the following portions of certain streets where no person shall park a vehicle:

Section 2. That Schedule J of §14-4, entitled "Parking Prohibited During Certain Hours on Certain Streets", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following portions of certain streets where no person shall park a vehicle:

No Parking 2AM - 6AM Every Day But Only Nov. 1 - March 31SpringfieldWestboundFrom Lincoln to WrightNorthSpringfieldEastboundFrom Goodwin to LincolnSouth

Section 3. That Schedule M of §14-10, entitled "Tow Away Zones", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following portions of certain streets which shall be established as tow away zones:

Tow-Away	Zone, 2AM	- 6AM, Nov.	1 - March	31, 7 Days Week
Springfield	Lincoln	Wright		North
Springfield	Goodwin	Lincoln		South

<u>Section 4.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 5. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.
