

ORDINANCE NO. 9495-100

AN ORDINANCE AMENDING ORDINANCE NO. 9495-97 ENTITLED
"AN ORDINANCE AMENDING CHAPTER TEN OF THE CODE OF ORDINANCES,
CITY OF URBANA, ILLINOIS REGULATING THE LICENSING OF HAULERS"

BE IT ORDAINED BY THE URBANA CITY COUNCIL as follows:

Section 1. Ordinance No. 9495- 97 , entitled "An Ordinance Amending Chapter Ten of the Code of Ordinances, City of Urbana, Illinois Regulating the Licensing of Haulers" is hereby amended in the following respects:

- (a) Section 1, Sec. 10-21 is amended to read as follows:
"Each Hauler license shall expire on June thirtieth of each year, provided, however, any license issued prior to June 30, 1995 shall not expire until June 30, 1996."
- (b) Sec. 10-22(A)(3) is hereby amended to read as follows:

"year, make, model, type, and Illinois vehicle plate number of each collection vehicle to be operated by the business within the City;"
- (c) Sec. 10-22(C) is hereby amended to read as follows:

"A new application shall be required to be submitted to the approving authority no later than May 15 of each year prior to issuance of a Hauler license, provided, however, application for licenses to be valid until June 30, 1996 may be submitted any time prior to June 30, 1995."
- (d) Section 14 is hereby amended to read as follows:

"This Ordinance shall be effective on July 1, 1995, except for Section 10-21 and 10-22 which sections shall become effective ten (10) days after publication in accordance with Section 1-2-4 of the Illinois Municipal Code."

Section 2. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect ten (10) days from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.


