## ORDINANCE NO. 9596-13

## AMENDMENT TO A PART OF THE ZONING ORDINANCE OF THE CITY OF URBANA, ILLINOIS AND THE ZONING MAP OF URBANA, ILLINOIS

#### **Deerfield Trails Subdivision**

(Plan Case No. 1576-M-95)

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on July 20, 1995 concerning the Petition filed by the Zoning Administrator at the request of the Deerfield Trails Subdivision Homeowner's Association in Plan Case #1576-M-95; and

WHEREAS, the Urbana Plan Commission has forwarded the case to the Urbana City Council with a recommendation to approve the requested rezoning of the property herein described below and commonly known as part of Deerfield Trails Subdivision R-4, Medium Density Multiple Family Residential to R-2 Single Family Residential; and

WHEREAS, said requested rezoning is consistent with the intent of the Official Comprehensive Plan Map and with the Goals, Objectives and Policies of the 1982 Comprehensive Plan, as amended.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, THAT:

<u>Section 1.</u> The Zoning Ordinance of the City of Urbana and the Zoning Map of Urbana, Illinois, are herewith and hereby amended to change the zoning classification of the following described area so that the property commonly known as part of Deerfield Trails Subdivision will be rezoned from R-4, Medium Density Multiple Family Residential to R-2 Single Family Residential:

1502, 1504, 1506, 1507, 1508, 1509, 1510, 1601, 1602, 1603, 1604, 1605, 1606, 1607, 1608, 1610 and 1701 Trails Drive. 3201, 3202, 3203, 3204, 3205, 3206, 3207, 3208 and 3209 Fawn Hill Court. 3203, 3204, 3205, 3206, 3207, 3208, 3209, and 3210 Baronry Drive. 3206, 3207, 3208, 3209A, 3209B, 3210, 3211, 3212 and 3214 Chatham Circle

The properties are described more particularly as follows:

All of each of the following lots in the Deerfield Trails First Subdivision as per plat recorded as document no. 78, R15349 in Book Z at page 23 in the Office of the Champaign County Recorder of Deeds, all of said lots being situated in the City of Urbana, Champaign County, Illinois: Lot 1 through and including lot 31, and Lot 45


