### ORDINANCE NO. 9596-2

### AN ORDINANCE RELEASING AN EASEMENT IN THE FAIRLAWN PARK SUBDIVISION

WHEREAS, the plat of Fairlawn Park Subdivision, dated April 29, 1950 and recorded June 6, 1950 as Document 458796 in Plat Book 1 of Page 24 in the Office of the Recorder of Deeds of Champaign County, Illinois, depicted a certain easement ten feet (10') in width running along the North side of Lot 86 thereof, for the entire east/west dimension of Lot 86; and

WHEREAS, all utility companies and the Urbana Champaign Sanitary District have indicated they have made no use of such easement and do not have any present plans to use the easement and consent to the releasing of said easement; and

WHEREAS, the Urbana City Council has found that it is in the best interests of all concerned that the subject easement be released contingent upon the owners of record of Lot 86 granting to the City of Urbana a new easement of lesser square footage which will be useful to the public.

NOW THEREFORE, BE IT ORDAINED BY THE URBANA CITY COUNCIL AS FOLLOWS:

Section 1. That the easement shown on a plat dated April 29, 1950 and recorded June 6, 1950 as Document No. 458796 in Plat Book I at Page 24 in the Office of the Recorder of Deeds, Champaign County, Illinois, described as the northerly ten feet (10') of even and equal width of Lot 86, excepting therefrom the westerly five feet (5') of even and equal width of the northerly ten feet (10') of even and equal width of said Lot 86, is hereby released, vacated and extinguished upon a certified copy of this Ordinance being recorded with the Recorder of Deeds, Champaign County, Illinois.

Section 2. That the City Clerk shall not record a certified copy of this Ordinance unless the Clerk receives a grant of easement for utilities from the current owner of record of Lot 86 over the easterly five feet (5.00') of even and equal width, of the westerly ten feet (10.00') of even and equal width of the northerly fifteen feet (15.00') of even and equal width of said Lot 86 and endorse on the original copy of this Ordinance that such has been received.

<u>Section 3.</u> The plat attached hereto is incorporated in this Ordinance by reference.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a three-fourths (3/4th's) vote of the members of the City Council of the City of Urbana, Illinois, at a regular meeting of said City Council.






## LOCATION MAP
