## **ORDINANCE NO.** 9596-44

## AN ORDINANCE AMENDING SECTION 14-12 OF THE URBANA LOCAL TRAFFIC CODE REGARDING PARKING PERMITS

(West Urbana Parking Zone)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

- Section 1. That Section 14-12, entitled "Parking Permits" of Title XIV of the Urbana Local Traffic Code, Paragraph A, Subsection (1) is hereby amended to read as follows:
- (A) (1) The West Urbana Parking Zone shall be the area bounded by Green Street, Race Street, Florida Avenue, and Lincoln Avenue. The Zone shall include Florida Avenue. The Zone shall not include Green Street, Race Street, or Lincoln Avenue.
- <u>Section 2.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.
- Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.
- Section 4. The city Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
