ORDINANCE NO. 9596-55

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 8-3 AND SCHEDULE I OF SECTION 8-4 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT CERTAIN INTERSECTIONS AND REMOVING YIELD SIGNS AT CERTAIN INTERSECTIONS

(Maple, Webber, McCullough, Geraldine, Highland, Berkley)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule I of Section 8-4, entitled "Yield Signs Pursuant to Section 8-4" of Article VIII of the Urbana Local Traffic Code, is hereby amended by deleting from that schedule the following intersections where drivers of vehicles shall be required to yield before entering the intersection:

Section 2. That Schedule H of Section 8-3, entitled "Stop Signs Pursuant to Section 8-3" of Article VIII of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersection:

Maple	Southbound	California
Webber	Northbound	California
Webber	Southbound	California
McCullough	Northbound	Nevada
McCullough	Southbound	Nevada
Geraldine	Southbound	Kerr
Highland	Southbound	Kerr
Berkley	Southbound	Kerr

<u>Section 3.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 4. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired or existing prior to the effective date of this ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this ordinance.
