ORDINANCE NO. 9596-66

AN ORDINANCE AMENDING CHAPTER 12, "HUMAN RIGHTS" OF THE CODE OF ORDINANCES OF THE CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE URBANA CITY COUNCIL that Chapter 12 of the Code of Ordinances of the City of Urbana, Illinois, entitled "HUMAN RIGHTS", is hereby amended as follows:

Section 1.

Section 12-39 is amended to add the following underlined language:

Sec. 12-39. Definitions.

* * *

Discrimination. Any practice or act which is unlawfully based wholly or partially on the race, color, creed, class, national origin, religion, sex, age, marital status, physical or mental handicap, personal appearance, sexual preference, family responsibilities, matriculation, political affiliation, prior arrest or conviction record or source of income of any individual, or any subclass of the above groups.

* * *

Matriculation. The condition of being enrolled in college or a university, whether as an undergraduate, graduate or professional student in any area of study, full-time or part-time, in either a degree or non-degree program, or in a business, nursing, professional, secretarial, technical or vocational school or an adult educational program.

* *

Source of income. The point or form of the origination of legal gains of income accruing to a person in a stated period of time; from any occupation, profession or activity, from any contract, agreement or settlement, from federal, state or local payments, including Section 8 or any other rent subsidy or rent assistance program, from court ordered payments, or from payments received as gifts, bequests, annuities, or life insurance policies.

Section 2.

All ordinances, resolutions or motions or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3.

The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a special meeting of said Council held upon proper notice.
