ORDINANCE NO. 9596-66A

AN ORDINANCE AMENDING SECTION 12-37 OF CHAPTER 12. "HUMAN RIGHTS," OF THE CODE OF ORDINANCES OF THE CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE URBANA CITY COUNCIL that Chapter 12 of the Code of Ordinances of the City of Urbana, Illinois, entitled "HUMAN RIGHTS", is amended as follows:

Section 1.

Section 12-37 is amended to add the following underlined language:

Sec. 12-37. Intent and purpose.

It is the intent of the City of Urbana in adopting this article, to secure an end, in the city, to discrimination, including, but not limited to, discrimination by reason of race, color, creed, class, national origin, religion, sex, age, marital status, physical and mental handicap, personal appearance, sexual preference, family responsibilities, matriculation, political affiliation, prior arrest or conviction record or source of income, or any other discrimination based upon categorizing or classifying a person rather than evaluating a person's unique qualifications relevant to an opportunity in housing, employment, credit or access to public accommodations.

Section 2.

All ordinances, resolutions or motions, or parts of them, that conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3.

The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of the Council.

The City Council of the City of Urbana, Illinois met in special session at 8:00 p.m., Monday, January 22, 1996 in the Council Chambers of the Urbana City Building.

There being a quorum, the meeting was called to order at $8:03\ p.m.$ by Mayor Satterthwaite.

Gregory L. Ryan, 1402 Adams, attorney representing Town & Country Apartments, addressed the Council in opposition to the Human Rights Ordinance.

Alderwoman Patt moved to approve An Ordinance Amending Chapter 12, "Human Rights" Of The Code Of Ordinances Of The City Of Urbana, Illinois, amended to add in Section 12-37. Intent and Purpose, following "prior arrest or conviction record or source of income" the following: "or any other discrimination based upon categorizing or classifying a person rather than evaluating a person's unique qualifications relevant to an opportunity in housing, employment, credit or access to public accommodations." Also, in Section 12-39. Definitions. Matriculation. following "The condition of being enrolled in college or a university," add: "whether as an undergraduate, graduate or professional student in any area of study, full-time or part-time, in either a degree or non-degree program,". Under Source of Income. following "from federal, state or local payments, "include: "including Section 8 or any other rent subsidy or rent assistance program, ". Alderwoman Ryan inquired if Alderwoman Patt intended to include the language fro Staff under Section 12-39 under Definition of Discrimination where it was also added "or any sub-class of the above groups"? Alderwoman Patt indicated that was her intent. The motion was seconded by Alderwoman Ryan.

Following debate, Alderman Taylor moved to table Section

The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, February 5, 1996 in the Council Chambers of the Urbana City Building.

There being a quorum, the meeting was called to order at 7:30 p.m. by Mayor Tod Satterthwaite.

MINUTES OF PREVIOUS MEETING

Alderman Taylor moved to approve the minutes of the January 16, 1996 regular meeting and the January 22, 1996 special meeting. The motion was seconded by Alderwoman Kearns.

Alderwoman Ryan stated that on page four of the minutes of the January 16, 1996 regular meeting, her vote on the amendments to the guidelines was incorrectly recorded as an aye, it was a nay.

Alderwoman Patt stated that on the January 22, 1996 minutes, on page 2, the sixth line down in the sentence which begins with the word "categorizing" between categorizing and relevant should be the words "or classifying a person rather than evaluating a person's unique qualifications". Also, on that same page where it says 21-39, it should read 12-39. Also prior to

the second by Alderwoman Ryan, it should state the following:
"Alderwoman Ryan inquired if Alderwoman Patt intended to include

PETITIONS AND COMMUNICATIONS

Earl O'Shea, 606A South Glover, offered his opinion of the construction in progress at the City Building and also of the administration of the government of the City of Urbana.

Alderman Whelan addressed the public to clarify issues that he felt were misquoted in the news papers. Recently Alderman Whelan was quoted in the News-Gazette as saying that "Urbana is becoming a dictatorship of the proletariat after the City Council added renters' rights protection to the City Human Rights Ordinance." His statement was in regard to the Section 8 subsidies and the HUD lease taking precedence over landlord leases, he did support the undergraduate student rights portion of the ordinance.

Alderman Whelan stated that the Daily Illini had reported that "his spirited defense of landlords' rights was a tirade".

The words used color an article. Alderman Whelan stated that he

felt what he was offering was "a spirited defense of landlords' rights and not a tirade against the proponents of this subordination of landlords' rights to HUD's regulations."

Alderman Hayes congratulated Rick Rose of the Fire

Department and Pat Connelly of the Police Department for being voted outstanding fireman and policeman from their respective departments, stating that is was a great honor because they were selected by their peers.

Alderman Hayes also acknowledged members of the Fire Department, Mike Mabry, Harry Jackson, and Dwayne Bishop for their assistance in delivering a baby at the Lincoln Trailer Park.

Alderman Hayes stated that February is Black History Month and urged members of the community to get out into the community to observe the special programs being presented to acknowledge contributions of Black Americans.

Mayor Satterthwaite introduced Al Anderson, who is the new Director of Metcad.
