#### ORDINANCE NO. 9596-69

AN ORDINANCE AMENDING SECTION 14-7 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING IN SPECIFIED PLACES

#### (COTTAGE GROVE AVENUE AT BURKWOOD)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

<u>Section 1.</u> That Schedule L of §14-7, entitled "Parking Prohibited in Specified Places", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following curbing that is to be painted yellow:

Street	From To	Side of Street
Cottage Grove	From the centerline of Burkwood	East
	to 60 feet south of Burkwood	

Cottage Grove From 290 feet south of the centerline East of Burkwood to 305 feet south of the centerline of Burkwood

<u>Section 2.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.


