ORDINANCE NO.9596-75

AN ORDINANCE ENACTING SECTION 4-47 TO THE URBANA CITY CODE (Removal of Dog Excrement)

BE IT ORDAINED BY THE URBANA CITY COUNCIL as follows:

<u>Section 1.</u> The following new Section is hereby enacted:

"Sec. 4-47. Removal of Dog Excrement. Each owner of a dog shall be responsible for the prompt removal of all fecal matter deposited by the dog owned by such person, if such deposit of fecal matter is made on any property which is not owned or possessed under lease by such person. The fecal matter removed must be disposed of properly. Any person, when in possession or control of a dog (even though not the owner of the dog), is responsible for the same duties imposed herein as are imposed on the owner of the dog.

A blind person in control of a guide dog shall be exempt from the provisions of this Section.

Any person violating the provisions of this Section shall, upon conviction thereof, be fined in an amount not to exceed \$500.00."

Section 2. Section 1-18 of the Urbana City Code is also amended to add the following:

"4-47. Removal of Dog Excrement.....\$50.00"

Section 3. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
