ORDINANCE NO. 9697-12

AN ORDINANCE AMENDING SCHEDULES K AND L OF THE URBANA LOCAL TRAFFIC CODE RELATING TO PARKING ON COLER AVENUE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. The Mayor having directed and the City Council hereby approving such direction, the following described parking meter zone is established pursuant to Section 17-1 of Article XVII entitled "Parking Meters" of the Urbana Local Traffic Code.

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
Coler Avenue	236' North of the centerline of Main Street (approximately 3 spaces)	174' North of the centerline of Main Street	West

Section 2. That Schedule K is hereby amended to add a new section to read as follows:

"No Parking 10:00 a.m. to 4:00 p.m. Monday through Friday

<u>Street</u>	<u>Direction of Travel</u>	<u>Location</u>	<u>Side of Street</u>
Coler	Southbound	174' North of the centerline of Main Street to 69' North of the centerline of Main Street (approximately 5 spaces)	West

Section 3. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
