

AN ORDINANCE AMENDING SECTIONS 17-8 AND 17-14
OF THE URBANA LOCAL TRAFFIC CODE

DEFEATED

DATE: August 5, 1996

BE IT ORDAINED BY THE URBANA CITY COUNCIL THAT:

Section 1. Subsection 17-8(B) is hereby amended to read as follows:

"(B) The parking time limits for each parking space controlled by a parking meter shall be established by either the City Council by ordinance or by the Director of Public Works under the authority of the power herein delegated; regardless of whether such parking time limit is established by the Director of Public Works or the City Council, such time limit shall be based upon consideration of the following factors:

- (1) The intensity of use of such parking space;
- (2) The demand for long-term parking availability in the area;
- (3) The demand for short-term parking availability in the area; and
- (4) Other traffic conditions and hazards.

The authority of the Director of Public Works to change the parking time limit shall not extend to any meter for which the City Council has established the parking time limit, until the Council directs otherwise."

Section 2. Subsection 17-14(C)(1) is hereby amended to read as follows:

"(1) Unless directed otherwise by ordinance, with respect to a particular meter or meters, all meters controlling parking on dedicated right-of-ways shall be enforced between the hours of 7:00 a.m. and 6:00 p.m., Monday through Saturday."

Section 3. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
