

AN ORDINANCE ESTABLISHING A PARKING METER ZONE, AND AMENDING SCHEDULE J OF SECTION 14-3 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING ON CERTAIN STREETS

(Park St., Church St., McCullough St.)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. The Mayor having directed and the City Council hereby approving such direction, the following described parking meter zone is established pursuant to § 17-1 of Article XVII entitled "Parking Meters" of the Urbana Local Traffic Code:

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
Park St.	Lincoln Av.	Coler Av.	South

Section 2. That Schedule J of §14-3, entitled "Parking Prohibited at All Times on Certain Streets", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule, under the heading, "**No Parking Either Side**" the following portions of streets where no person shall park a vehicle:

Church St.	From Lincoln Av. to Park St.
McCullough St.	From Park St. to University Av.

Section 3. That Schedule J of §14-3, entitled "Parking Prohibited at All Times on Certain Streets", of Article XIV of the Urbana Local Traffic Code, is hereby amended by deleting the language shown in strikeout type, under the heading, "**No Parking This Side of Street**" as follows:

Church	Westbound	400 Feet Past Busey	North
Church	Westbound	100 Feet Past Coler	North

Section 4. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 5. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 6. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect

from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

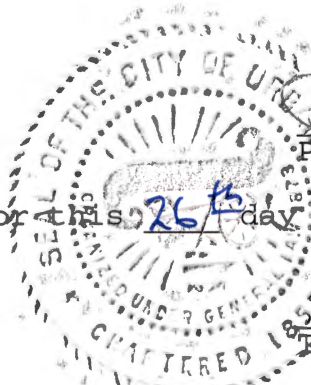

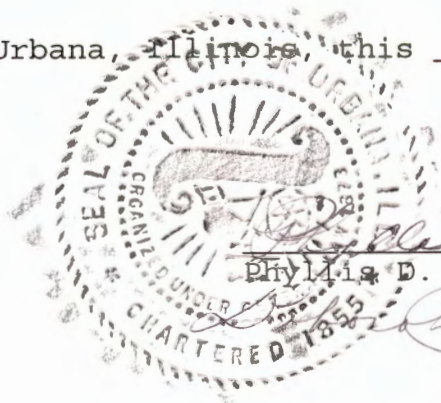
