ORDINANCE NO. 9697-4

**DATE:** August 19, 1996

AN ORDINANCE AMENDING SCHEDULE L OF SECTION 17-1 OF ARTICLE XVII OF THE URBANA LOCAL TRAFFIC CODE ESTABLISHING PARKING METER ZONES (Clark Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. The Mayor having directed and the City Council hereby approving such direction, the following described parking meter zone is established pursuant to Section 17-1 of Article XVII entitled "Parking Meters" of the Urbana Local Traffic Code.

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
Clark Street	70' East of the centerline of Busey to 100' West of the centerline of Coler (approximately 14 spaces)		South

Section 2. The City Council, having given due consideration to the intensity of use of such parking spaces and the demand for both long-term and short-term parking availability in the area and other traffic conditions and hazards, hereby establishes that the parking time limits for each of the parking spaces identified in Section 1 of this Ordinance shall be two hours.

Section 3. The hours of enforcement for the parking meters identified in Section 1 of this Ordinance shall be from \_\_\_\_\_ a.m. to \_\_\_\_\_ p.m. Monday through Saturday.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
