AN ORDINANCE RELEASING AN EASEMENT IN THE ENNIS RIDGE
EIGHTH SUBDIVISION (REPLAT)
(803 and 901 East Brighton)

WHEREAS, the plat of Ennis Ridge Eighth Subdivision (Replat) recorded in Plat Book "P" at page 9 in the Office of the Recorder of Deeds, Champaign County, Illinois, depicted a certain easement 10.00' in width running adjacent to the east and south lines of Lot 603 of the said Ennis Ridge Eighth Subdivision (Replat); and

WHEREAS, on the face of the said plat this 10.00' strip of land is labeled: 10.00' sidewalk and was apparently intended to be a sidewalk right-of-way for the convenient access to Yankee Ridge School; the School District has advised that it has no objection to abandoning the sidewalk right-of-way easement; and

WHEREAS, no paved surface was ever installed in the said easement; and

WHEREAS, the owner of Lot 603 of Ennis Ridge Eighth Subdivision (Replat) and the owners of Lots 688 and 700 in Ennis Ridge Ninth Subdivision have requested that the City release, abandon and vacate the said sidewalk right-of-way easement; and

WHEREAS, although not needed for any sidewalk right-of-way purposes, the said described easement would be useful as a utility easement; and

WHEREAS, the Urbana City Council finds that it is in the best interests of all concerned that the portion of the subject sidewalk right-of-way easement described below be released, vacated and abandoned and in accordance with statute, the title to the land over which the aforesaid sidewalk right-of-way easement runs shall devolve and vest in the present owners of the land abutting thereon in the same proportion and to the same extent as though the sidewalk right-of-way easement had been dedicated by a common law plat (as distinguished from a statutory plat) and as though the fee of the sidewalk right-of-way easement had been acquired by the owner as part of the land abutting on the sidewalk right-of-way easement, if immediately after so acquiring fee title to that portion of the abandoned sidewalk right-of-way abutting their property, the owner of Lot 603 of Ennis Ridge Eighth Subdivision (Replat) and the owners of Lots 688 and 700 of Ennis Ridge Ninth Subdivision dedicate an easement for utility purposes that same area that was formerly intended to be sidewalk right-of-way easement.

NOW THEREFORE, BE IT ORDAINED BY THE URBANA CITY COUNCIL as follows:

THIS ORDINANCE CONSISTS OF 3 PAGES.

Section 1. That the portion of the sidewalk right-of-way easement shown on the Plat of Subdivision of Ennis Ridge Eighth Subdivision (Replat) as recorded in Plat Book "P" at page 9 in the Office of the Recorder of Deeds, Champaign County, Illinois, depicted as easement 10.00' in width running adjacent to the east and south lines of Lot 603 of the said Eighth Subdivision (Replat) which is more fully described immediately below is hereby released, abandoned and vacated upon the condition set forth in Section 2 being fulfilled and the recording of a certified copy of this Ordinance being recorded with the Recorder of Deeds, Champaign County, Illinois.

Beginning at the northeast corner of Lot 603 in Ennis Ridge Eighth Subdivision (Replat) Champaign County, Illinois, per plat recorded in Plat Book at page 9, in the Office of the Recorder, Champaign County, Illinois; thence, East 10.00 feet, along the south Right-of-Way line of Brighton Drive to the northwest corner of Lot 688 in Ennis Ridge Ninth Subdivision Champaign County, Illinois, per plat recorded in Plat Book P at page 51, in the Office of the Recorder, Champaign County, Illinois; thence, South, along the west line of said Lot 688, said line also being the east line of a sidewalk easement shown on said Ennis Ridge Eighth Subdivision Replat, 114.00 feet to the southwest corner of said Lot 688; thence, continuing South, along said east line of a sidewalk easement, said line also being a west line of Lot 700 of said Ennis Ridge Ninth Subdivision 5.00 feet to a corner of said Lot 700; thence, West along a north line of said Lot 700, 107.00 feet to the southerly extension of the west line of said Lot 603; thence, North along the southerly extension of the west line of said Lot 603, 10.00 feet to the southwest corner of said Lot 603; thence, East along the south line of said Lot 603, 97.00 feet to the southeast corner of said Lot 603; thence, North along the east line of said Lot 603, 109.00 feet to the point of beginning. Containing 0.05 acre and situated in the City of Urbana, Illinois.

Section 2. The release, abandonment and vacation of the above-said sidewalk right-of-way easement shall become effective only upon acceptance of by the City Engineer and the recordation of a dedication of utility easements of the same dimensions as the sidewalk right-of-way herein vacated, from the owners of Lot 603 of Ennis Ridge Eighth Subdivision (Replat) and Lots 688 and 700 of Ennis Ridge Ninth Subdivision. Acknowledgement by the City Engineer that such dedications have been duly accepted and recorded shall be conclusive of the satisfaction of such contingency and condition.

Section 3. That if the City Engineer so certifies as is set forth in Section 2 above, the City Clerk shall record a certified copy of this Ordinance in the Recorder's Office of Champaign County, Illinois.

Section 4. That the plat of vacation attached hereto is incorporated in this Ordinance by reference.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called by a of three-fourth's (3/4th's) vote of the members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council.



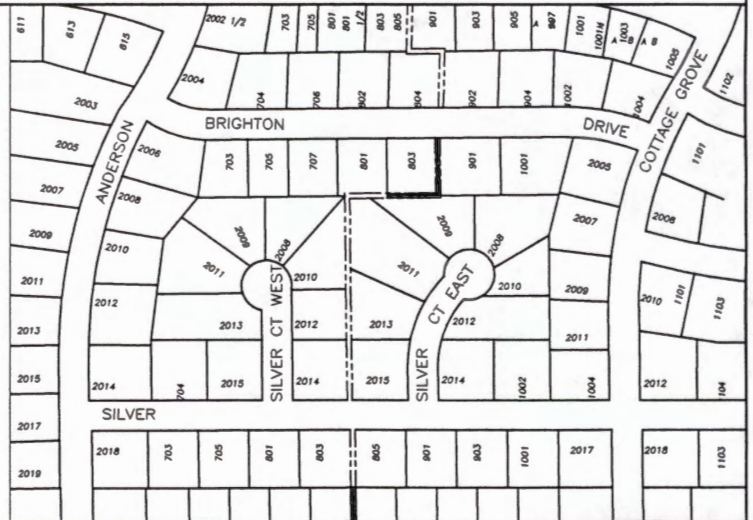
NORTH LINE OF LOT 700

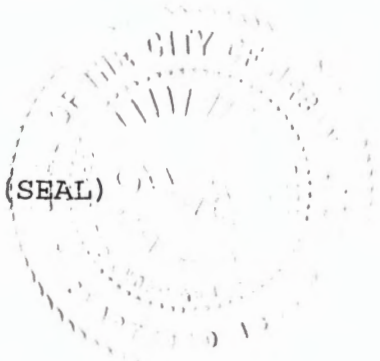
