

ORDINANCE NO. 9697-103A

AN ORDINANCE AMENDING SECTION 10-4(b) OF THE URBANA CODE OF  
ORDINANCES ENTITLED "CURBSIDE COLLECTION; SCHEDULE"  
(Amending Existing Garbage Zones)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That subsection (b) of Section 10-4 of Chapter 10 of the Urbana Code of Ordinances is hereby amended to read as follows:

"(b) (1) Except for persons collecting recyclable materials pursuant to a contract with the City, the schedule allowing curbside collection to occur shall be in the following areas within the City only on the designated days as provided herein:

- a. Monday: the geographical area which is located South of **and including both sides of** Illinois Street and the extension thereof, and West of **and including both sides of** Anderson Street and the extension thereof; and
- b. Tuesday: the geographical area which is located South of **and including both sides of** Illinois Street and the extension thereof, and East of Anderson Street and the extension thereof; and
- c. Wednesday: the geographical area which is located North of Illinois Street and the extension thereof.

If a City observed holiday should occur on one of the designated days, Haulers will be allowed to provide curbside collection on the day following the holiday for that geographical area. The occurrence of such holiday may impact subsequent designated curbside collection days, therefore, if such holiday should occur on Monday, that geographical area will be allowed to be collected on Tuesday; if Tuesday, that geographical area will be allowed to be collected on Wednesday; if Wednesday, that geographical area will be allowed to be collected on Thursday; for the remainder of such week.

(2) Curbside collection of recyclable materials by a person operating pursuant to a contract with the City may occur as provided in such contract."

Section 2. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

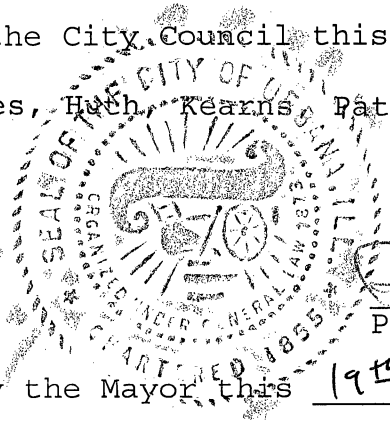

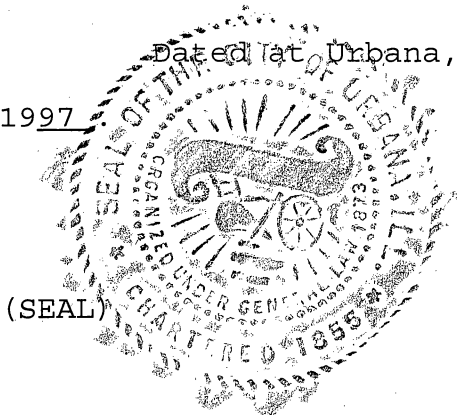
