#### **ORDINANCE NO. 9697-114**

## AN AMENDMENT TO THE COMPREHENSIVE PLAN MAP OF THE CITY OF URBANA, ILLINOIS

#### (604-702 ½ E. Main, Plan Case No. 1646-CP-97)

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on March 20, 1997 concerning the petition filed by Jay Goff on behalf of Autozone in Plan Case #1646-CP-97; and

WHEREAS, the Urbana Plan Commission voted 6-0 to forward the case to the Urbana City Council with a recommendation to approve the request so that the Comprehensive Plan designation of the properties herein described below and commonly known as 604-702 ½ E. Main will be changed from Industrial and Commercial to Commercial; and

WHEREAS, the requested Comprehensive Plan Amendment conforms to the goals and objectives of the City of Urbana's Comprehensive Plan, as amended; and

WHEREAS, the Urbana City Council has determined it is in the best interests of the citizens of the City of Urbana to amend the Comprehensive Plan:

NOW, THEREAFTER, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF URBANA, ILLINOIS, THAT:

<u>Section 1.</u> The petitioner's request to change the Comprehensive Plan designation of the following described area commonly known as 604-702 ½ E. Main from Industrial and Commercial to Commercial is hereby approved:

A part of Lots 1, 2, and 3 in Fisher's Replat, being a subdivision of a part of Lot 9 and 10 of a subdivision of the West Half of the Southwest Quarter of Section 9, and the East Half of the Southeast Quarter of Section 8, as recorded in Plat Book "C", Page 308 at the Champaign County Recorder's Office, and Lots 4, 6, and 10 and the portion of alley which adjoins Lot 10 described and vacated by Ordinance Number 9091-58, dated November 19, 1990 by the City of Urbana, Illinois, in Munhall's Elm Tree Addition, being a subdivision of Lot 5 of a subdivision of Lot 9 of a subdivision of the East Half of the Southeast Quarter of Section 8 and the West Half of the Southwest Quarter of Section 9, as recorded in Plat Book "B", Page 230 at the Champaign County Recorder's Office, and a parcel of land as described in Quit Claim Deed recorded in Book 1667, Page 411, dated November 28, 1989, being a part of Lot 10 of a subdivision of the East Half of the Southeast Quarter of Section 8 and the West Half of the Southwest Quarter of Section 9, all being in Township 19 North, Range 9 East of the Third Principal Meridian, situated in the City of Urbana, Illinois, being more particularly described as follows:

Commencing at the Southeast corner of Lot 4 of said Munhall's Elm Tree Addition as the POINT OF BEGINNING of the tract to be described, said point also being on the North right-of-way line of East Main Street: thence North 000-40'-53" West (bearings assumed for the purpose of description only) along the East line of said Lot 4, a distance of 180.01 feet to the Northeast corner of said Lot 4; thence North 89°-20'-38" East, a distance of 6.00 feet to the centerline of a vacated alley; thence North 00°-40'-53" West along the centerline of a vacated alley, a distance of 160.87 feet to a point on the Southeasterly right-of-way line of an alley; thence South 63°-23'-06" West along the Southeasterly right-of-way line of an alley, a distance of 6.67 feet to a point on the East line of Lot 10 of said Munhall's Elm Tree Addition; thence North 00°-40'-53" West along the East line on said Lot 10, a distance of 13.34 feet to the Northeast corner of said Lot 10, said point also being the prior Southerly right-of-way line of Conrail (Peoria and Eastern Railway/C.C.C. and St. Louis Rail Road/Penn Central Rail Road); thence South 63<sup>0</sup>-23'-06" West along the Northerly line of said Munhall's Elm Tree Addition, a distance of 69.67 feet; thence South 56°-58'-49" West along the Northerly Line of said Munhall's Elm Tree Addition and the Northerly line of said Fisher's Replat, a distance of 15.88 feet: thence South 88°-42'-03" West along the Northerly line of said Fisher's Replat, a distance of 15.88 feet; thence South 640-45'-15" West along the Northerly line of said Fisher's Replat, a distance of 81.49 feet; thence South 25°-47'-18" West along the Northerly line of said Fisher's Replat, a distance of 90.27 feet to a Northwesterly corner of Lot 1 of said Fisher's Replat; thence South 89°-21'-00" West parallel with the North right-of-way line of East Main Street, a distance of 10.36 feet to a point on the Easterly side of an existing woven wire fence (as described in said Quit Claim Deed recorded in Book 1667, Page 411); thence South 08<sup>0</sup>-30'-44" East along the Easterly side of said existing woven wire fence, a distance of 28.72 feet; then South 000-29'-37" East along the Easterly side of said existing woven wire fence, a distance of 145.95 feet; thence South 060-17'-24" West along the Easterly side of said existing woven fire fence, a distance of 23.14 feet to a point on the North right-of-way line of East Main Street; thence North 89<sup>o</sup>-21'-00" East along the North right-of-way line of East Main Street, a distance of 216.04 feet to the to the POINT OF BEGINNING, containing 1.471 acres, more or less, situated, lying and being in the County of Champaign and State of Illinois.

The said area above described being represented on the map attached hereto and incorporated herein by reference.

<u>Section 2.</u> The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities. This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Chapter 65, Section 1-2-4 of the Illinois Compiled Statutes (65 ILCS 5/1-2-4).

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a super-majority of the Members of the City Council of the City of Urbana, Illinois, at a special meeting of said Council.


