AN AMENDMENT TO A PART OF THE ZONING ORDINANCE OF THE CITY OF URBANA, ILLINOIS AND THE ZONING MAP OF URBANA, ILLINOIS

(Request to Rezone Property Located on Killarney Street and Linview Avenue from IN Industrial to B-3 General Business) Plan Case No. 1656-M-97

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on May 8, 1997 concerning the Petition filed by the Zoning Administrator in Plan Case #1656-M-97; and

WHEREAS, the Urbana Plan Commission has forwarded the case to the Urbana City Council with a recommendation to approve the request so that the property herein described below will be rezoned from IN Industrial to B-3 General Business; and,

The said area above described being represented on the map attached hereto and incorporated herein by reference.

<u>Section 2.</u> The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.


