ORDINANCE NO. 9697-69

AN ORDINANCE VACATING A PORTION OF ELM STREET (Jumer's)

WHEREAS, the vacation of the portion of Elm Street, as provided herein, is in conformance with a prior agreement approved by Ordinance No. 8384-21 which was passed by the Urbana City Council on the 17th day of October, 1983, and approved by the Mayor on the 21st day of October, 1983, which provided that the portion of Elm Street herein vacated would be released to Jumer's Castle Lodge, Inc., a Delaware Corporation, as set forth therein; and

WHEREAS, the vacation of the portion of Elm Street, as provided herein, will not interfere with or impair the access rights of any private property; and

WHEREAS, in accordance with the requirements of Ordinance No. 9293-97 entitled "An Ordinance Requiring a Public Hearing Prior to the Vacating of a Street", a public hearing was held on the 12th day of November, 1996, which said date was more than fifteen (15) days, but less than thirty (30) days following the publication of the Notice of Hearing in a newspaper of general circulation in the City of Urbana, to-wit, said publication having occurred on the 27th day of October, 1996; and the Zoning Administrator also caused to be mailed a copy of the said Notice so published to each of the last known taxpayers of record of all properties adjacent to or within 250' in each direction of the portion of the street proposed to be vacated, said mailing having been accomplished on the 4th day of November, 1996.

WHEREAS, the Urbana City Council has determined that the nature and extent of the public use and the public interest to be subserved, warrants the vacation of the portion of Elm Street as provided herein.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. The public street right-of-way described below is hereby vacated, reserving, however, any easement or easements in favor of the City or any public utilities, their successors or assigns, to operate, maintain, renew and reconstruct their facilities as now existing on, over or under that part of the street right-of-way described below, unless and until the owners of the land abutting thereon shall cause the rearrangement, removal or relocation of all said facilities, and shall pay and be responsible for all reasonable costs and expenses as shall be incurred in association therewith:

PARCEL 8 OF AN ALTA/ACSM LAND TITLE SURVEY OF THE JUMER'S CASTLE LODGE, INC. SITE, CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS, BY THOMAS B. BERNS DATED AUGUST 27, 1996 (UNRECORDED), FURTHER DESCRIBED AS FOLLOWS:

ALL AS SHOWN ON SAID ALTA/ACSM LAND TITLE SURVEY PREPARED BY THOMAS B. BERNS, DATED AUGUST 27, 1996, SAID TRACT BEING THE SAME TRACT REFERENCED IN A "GROUND LEASE WITH OPTION TO PURCHASE LEASED PREMISES AND FINANCING AGREEMENT" THAT WAS AUTHORIZED AND APPROVED BY THE CITY OF URBANA BY ORDINANCE NUMBER 8384-21, AND CONTAINING 3,970 SQUARE FEET (0.091 ACRES) MORE OR LESS, ALL AS SITUATED IN CHAMPAIGN COUNTY, ILLINOIS.

Section 2. Because the only private property which abuts upon the right-of-way herein vacated is property owned by Jumer's Castle Lodge, Inc., title to the vacated right-of-way shall vest in Jumer's Castle Lodge, Inc. at the time of passage of this Ordinance subject to the utility easements herein reserved.

<u>Section 3.</u> This Ordinance shall be effective immediately upon its passage and approval by the City Council of the City of Urbana, Illinois.

<u>Section 4.</u> The City Clerk is directed to record a certified copy of this Ordinance at the Office of the Recorder of Deeds, Champaign County, Illinois.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" having been called of three-fourths (3/4th's) of the members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council.
